FROM THE NURSE'S OFFICE

Students entering the 12th grade must show written proof of receiving two doses of meningococcal conjugate vaccine prior to entering the 12th grade. This proof must be provided to the nurse's office prior to the 2020/2021 distribution days. Please consult with your student's health care provider and consider turning in the documentation NOW to the School Nurse if your student is already compliant with this requirement.

Some important reminders:

- The first dose shall have been received on or after the 11th birthday, and
- The second dose shall have been received on or after the 16th birthday, at least eight weeks after the first dose.
- If the first dose is administered when the child is 16 years of age or older, only one dose is required.
