FAFSA INFORMATION

October 1st is the official opening date for the FAFSA. FAFSA (Free Application for Federal Student Aid) is a form that can be prepared annually by current and prospective college students in the United States to determine their eligibility for student financial aid.

This year, completing the FAFSA is a requirement for all Illinois graduating seniors! There is an Opt-Out form on the ISBE website that we will send out when the district decides on a deadline for those forms to be turned in.

FRESHMEN ADVISORY
